1.2.1. Presidents Report (Chair) - Attached Below

1.2.2. Treasurers Report (Ole) - Attached Below

It was agreed that we will continue with the audit period being calendar year. This will ensure closure of the finances align with the previous year's committee.

A check was presented for \$250. Given the age of the cheque, current treasurer did not have access to the old cheque books, so it took some investigating as to where it came from. After assistance from others, it was discovered the cheque was for P&C support of sports representative students from 2018.

Nicola has prepared details to engage the auditor for 2020 finances. There has been little activity this year so predicted audit will not take long. It was agreed that all auditing should wait until after December 31st to ensure accuracy of financial statements audit.

1.2.4. **Board Report (Aarthi)**

Thank you all for attending our October P&C meeting.

We have submitted 3 updates answering outstanding questions from the Community Services Directorate for our application of the Supporting Parental Engagement Grant. We remain confident of being granted funds in round 2. The Education Directorate has advised we are now able to hold events on school grounds if a maximum of 500 parents are in attendance. Whilst this is too late in the year to arrange and fundraising or community activity, it bodes well for next year's fundraising efforts if positive improvement continues into 2021.
